## Strategic Framework

The Operational Plan 2016/2017 (this document) details major projects, actions and activities to be undertaken by the PNP over the financial year to work towards the vision and achievement of the strategies outlined in the Strategic Plan 2016 -2019. The Plan is reviewed annually and aligns with PNP Member Local Governments annual budget processes. The Operation Plan is a 'living document' that will be evaluated annually

The Strategic Plan 2016 – 2019 establishes the Guiding Principles, Vision, Objectives and Strategic Direction of the PNP for the next four years and informs the annual operation plan. The Strategic Plan provides PNP Member Local Governments, stakeholders and the community with background and current information on the PNP and its strategic direction.

The Communications Strategy 2016 -2019 defines the approach that the PNP will undertake when communicating internally and externally to ensure the timely delivery of accurate and consistent information. The Communications Strategy aids in protecting PNP Member Local Governments' image and reputation.
